



# OFFICE OF THE HONOURABLE PRESIDENT CUSTOMARY COURT OF APPEAL FEDERAL CAPITAL TERRITORY JUDICIARY



In the exercise of the powers conferred on me by the provisions of Section 269 of the Constitution of the Federal Republic of Nigeria, 1999 (as amended), Section 20 of the Federal Capital Territory, Abuja Customary Court of Appeal Decree No. 30 of 1991, and by virtue of all other powers enabling me in that behalf, I, HON. JUSTICE ADEKUNLE STANLEY LAWAL, FICMC, F.DRI, President of the Customary Court of Appeal of the Federal Capital Territory, Abuja, hereby issue the following Practice Directions:

## 1. Applicability

This Practice Direction shall, save as may be otherwise directed by the Hon. President, apply to all Processes filed at the FCT Customary Court of Appeal and the FCT Customary Courts, in respect of all proceedings before the Courts.

## 2. Objective and Guiding Principles

The objective of this Practice Direction is to review and streamline fees payable for all Court Processes filed at the Registry of the FCT Customary Court of Appeal to reflect modern reality.

## 3. Directions

Notwithstanding any other directive to the contrary or in the time being, effective from the date of the coming into effect of this Practice Direction, the fees payable for all processes filed at the Registry of the FCT Customary Court of Appeal, Abuja, and the FCT Customary Courts shall be as listed on the attached Schedules I, II and III.

## 4. Citation

This Practice Direction shall be cited as the FCT Customary Court of Appeal (Review of Fees) Practice Direction No. 1 of 2026.

## 5. Commencement.

This Practice Direction shall commence and come into effect on the 1<sup>st</sup> day of March, 2026.
